**Rates:** For the 296 public fire hydrants owned and maintained by the Gardiner Water District (the District) and connected to the District's mains on January 1, 2025, there shall be paid to the District the following public fire protection charge:

**PRIVATE FIRE PROTECTION**

**Available:** To all customers using the Gardiner Water District's service for private fire protection. The following rates apply to fire protection only, and include no allowance for water other than fire fighting purposes.

**Rates:** Private fire service rates for automatic sprinklers, standpipes or hose connections to be used only for fire protection inside of buildings.

Service charge per inch of service pipe diameter, per year \$226.70

Each private hydrant with service connection furnished, installed and maintained by user for private fire protection, per year \$1,200.33
